Here is our explanation.

Tonight's GCRP Special Meeting was called to consider one resolution with three parts.

1. To give "... all necessary authority to the GCRP Executive Board to schedule and manage the 2023 GCRP ReOrg ..."

Do you really want to "give" people ALL NECESSARY AUTHORITY? These are people who presided over a "Purging of the RINOs" which resulted in your fellow officers deciding NOT to attend regular meetings because of the confusion and disunity at them.
