- Funds fully recovered following bank investigation and affidavit; incident referred to authorities.
- Discussion included questions on expense details and transparency.
- Report accepted.

Approval of Minutes

- Minutes from the June 2, 2025 regular meeting were presented for approval.
- Some members voiced concerns about the 6/2/2025 Meeting Minutes omitting agreed upon changes to the Treasurers Report moving forward. The Secretary clarified the video of the 6/2/2025 meeting is authoritative reference and expressed openness to receiving specific questions via email and will review the 6/2/2025 video. The Secretary found the Chair and Treasurer agreed to answer detailed questions via email but there was no agreement to make changes to the Treasurers Report from moving forward. The Secretary found both the Chair and Treasurer are willing to make changes if enough of the body asks for those changes.
- Minutes were approved contingent on 6/2/2025 video review.

State Executive Committeeman's Report

- Covered recent meetings (August 9 special; September 6 quarterly).
- Discussion included SCGOP's controversial decision regarding Pickens County organization recognition, priority of closing state open primaries, and criticism of state chairman's financial transparency.






Resolution to APPROVE

#ReOrg2027Schedule

WHEREAS, the Greenville County Republican Party (GCRP) Rules and/or the South Carolina Republican Party (SCGOP) Rules require approvals from the GCRP County Executive Committee related to schedule the 2027 Precinct Reorganization and County Convention (#ReOrg2027);

WHEREAS, the GCRP ReOrg Committee as well as the Executive Committee is recommending **Monday, March 1st at 7PM** as our ReOrg date, and **Saturday March April 1st at 10AM** as our Make-Up Date, and to delegate the finalization of the time and place for the April 2027 GCRP County Convention to the GCRP Chairman & 5th Vice Events Chair;

NOW, THEREFORE BE IT RESOLVED, the GCRP Executive Committee formally APPROVES the above ReOrg & Make-Up Dates and DELEGATES all necessary authority to the GCRP Chairman & 5th Vice Events Chair to finalize the time and place for the April 2027 GCRP County Convention.



Resolution of Support for Pickens County Republican Party

WHEREAS, all credible evidence confirms that the Pickens County Republican Party has conducted its Reorganization and County Convention in accordance with Party rules and principles; and

WHEREAS, concerns have been raised regarding proper recognition and representation of Pickens County at the State Executive Committee; and

WHEREAS, the South Carolina Republican Party has repeatedly called for unity, transparency, and respect for grassroots participation, yet the exclusion and suppression of Pickens County's duly elected delegates stands in direct conflict with those stated desires; and


WHEREAS, such actions diminish confidence in Party leadership and undermine the credibility of calls for unity, while placing political maneuvering above fairness and due process; and

WHEREAS, the strength of the South Carolina Republican Party depends upon honoring the will of its members at the local level, protecting their right to organize, and ensuring integrity in representation at the state level;

NOW, THEREFORE, BE IT RESOLVED, that the Greenville County Republican Party Executive Committee affirm our full support for the Pickens County Republican Party, its duly elected leadership, and its delegates; and

BE IT FURTHER RESOLVED, that we call upon the South Carolina Republican Party Executive Committee to recognize the lawful actions of the Pickens County Republican Party and to uphold their right to representation without obstruction, suppression, or conflicting standards; and

BE IT FINALLY RESOLVED, that this resolution be shared with all members of the South Carolina Republican Party Executive Committee as a statement of solidarity with Pickens County, in defense of grassroots Republican representation, and as a reminder that the Party must match its actions with its words.



Re-Censure of Greenville County Council Members Who Voted to Raise Taxes in 2023

WHEREAS, the Greenville County Republican Party (“GCRP”) exists to promote Republican values of limited government, fiscal responsibility, and accountability to the taxpayers of Greenville County; and

WHEREAS, in 2023, six of the ten Republican members of the Greenville County Council — **Dan Tripp, Joey Russo, Liz Seman, Butch Kirven, Mike Barnes, and Chris Harrison** — voted with two the democrats in favor of a property tax increase on Greenville County citizens; and

WHEREAS, this action represented a direct violation of the Republican Party Platform’s commitment to opposing unnecessary tax increases and reducing the size and scope of government; and

WHEREAS, the GCRP, on behalf of its members and the citizens of Greenville County, previously issued a formal censure of these Council members in 2023 to hold them accountable to Republican voters; and

WHEREAS, three of the censured Council members - **Butch Kirven, Mike Barnes, and Chris Harrison** (NOTE: Liz Seman ran unopposed) - were subsequently defeated in the June 2024 Republican Primary, confirming that Republican voters strongly disapproved of their tax-raising actions; and

WHEREAS, the three remaining Council members — **Dan Tripp, Joey Russo, and Liz Seman** — continue to serve in office and have made no public apology or corrective action for their votes to increase taxes on Greenville County residents; and

WHEREAS, the GCRP believes that the public must once again be reminded of the actions taken by **Dan Tripp and Joey Russo** before they stand for re-election in June 2026;

NOW, THEREFORE, BE IT RESOLVED, that the Greenville County Republican Party hereby reaffirms and reissues its CENSURE of **Dan Tripp, Joey Russo, and Liz Seman** for their 2023 votes to raise property taxes, in violation of core Republican fiscal principles; and

BE IT FURTHER RESOLVED, that this censure shall serve as a public notice to all Greenville County voters of these Council members’ record on taxation and fiscal policy, and as encouragement to seek and support candidates who uphold the Republican Party Platform.

Censure of Lt. Governor Pamela Evette for Failure to Support the MAGA / America First Movement in South Carolina

WHEREAS, the Greenville County Republican Party (“GCRP”) is the official Republican Party organization for Greenville County, South Carolina, duly elected by the grassroots Republican voters through the Reorganization process of 2021, 2023, and 2025; and

WHEREAS, since 2021, the GCRP has led the state and nation in advancing America First and MAGA values, including earning recognition as a **Top 5 National Trump Force 47 Call Banking Team** during the 2024 presidential campaign; and


WHEREAS, Lt. Governor Pamela Evette, a resident of Greenville County and now a declared candidate for Governor, is campaigning as a “Trump-supporting, MAGA candidate”; and

WHEREAS, Lt. Governor Evette has, over the past four and a half years, repeatedly refused to engage with the Greenville County Republican Party, declining every invitation to attend GCRP Business Meetings, dinners, cookouts, informational events, **TRUMP sign waves**, call banks, or the GCRP “Coffee & Politics” series — despite receiving numerous written invitations; and

WHEREAS, Lt. Governor Evette has publicly participated in numerous business and political events across the state — **including with establishment and anti-MAGA figures** — yet has shown complete disregard for the duly elected leadership and grassroots TRUMP Republicans of Greenville and other counties in SC; and

WHEREAS, in the 2021 SCGOP ReOrg process, credible evidence and documentation indicate that **Lt. Governor Evette and members of her family** were involved as “**harvested ballots**” in fraudulent participation supporting the RINO establishment against legitimate grassroots delegates; and

WHEREAS, Lt. Governor Evette has refused multiple requests from the GCRP Legislative Committee to meet and discuss legislative initiatives, especially “**real school choice**” — a top priority of the GCRP since 2021 — and instead aligned with establishment figures, including **Drew McKissick** and **Chad Connelly**, contributing to South Carolina now having *the worst rated school choice program in the nation*; and



Censure of Lt. Governor Pamela Evette for Failure to Support the MAGA / America First Movement in South Carolina

WHEREAS, Lt. Governor Evette has also been actively involved in supporting anti-MAGA efforts in other counties, including documented participation in the RINO-led removal of the America First leadership of the **Horry County Republican Party**; and

WHEREAS, her consistent pattern of refusal to engage with TRUMP grassroots conservatives, alignment with establishment insiders, and undermining of the MAGA / America First leadership contradicts the principles and values of the Republican Party and the MAGA movement she now claims to represent;

NOW, THEREFORE, BE IT RESOLVED, that the Greenville County Republican Party hereby CENSURES Lt. Governor Pamela Evette for her failure to support, engage with, or represent the Republican grassroots of Greenville County and South Carolina; and

BE IT FURTHER RESOLVED, that this censure serves as a formal public notice to Republican voters across South Carolina that Lt. Governor Pamela Evette's record and actions are inconsistent with the principles of the MAGA / America First movement; and

BE IT FURTHER RESOLVED, that the GCRP shall distribute this resolution publicly and to the South Carolina Republican Party, so voters may be fully informed of Lt. Governor Evette's record prior to the 2026 election cycle.

Censure of Dianne Mitchell for Her Leadership Role in the 2021 Greenville County Republican Party ReOrg FRAUD

WHEREAS, the Greenville County Republican Party (“GCRP”) exists to uphold the integrity of the Republican electoral process and to ensure transparency, accountability, and honesty in all Party operations; and

WHEREAS, during the 2021 Greenville County Republican Party Precinct Reorganization (“ReOrg”) process, widespread evidence emerged of **fraudulent activity involving “harvested ballots”**, irregular delegate submissions, and other violations of Republican Party rules and procedures; and

WHEREAS, at the time of these events, **Dianne Mitchell served as the 3rd Vice Chair of the GCRP**, holding a position of trust and responsibility in overseeing the conduct of the ReOrg process; and

WHEREAS, a **Special Committee Report**, commissioned and presented by members of the then GCRP leadership — essentially all of whom opposed the grassroots movement — nonetheless **confirmed substantial irregularities and fraudulent practices** during the 2021 ReOrg; and

WHEREAS, the findings of that Special Committee Report resulted in the **resignations in disgrace of the GCRP Chairman, 1st Vice Chairman, and State Executive Committeeman**, validating the concerns raised by grassroots Republican members; and

WHEREAS, despite these findings, **Dianne Mitchell has never publicly accepted responsibility** for her participation and leadership during the 2021 ReOrg process, nor has she expressed any regret or acknowledgment of the damage caused to the credibility of the GCRP and the Republican grassroots; and

WHEREAS, Dianne Mitchell is now a **declared candidate for the South Carolina House of Representatives, District 21**, seeking to represent the very voters who were disenfranchised and misled by the actions of the 2021 GCRP leadership team of which she was a part; and



Censure of Dianne Mitchell for Her Leadership Role in the 2021 Greenville County Republican Party ReOrg FRAUD

WHEREAS, the Greenville County Republican Party believes that **integrity, honesty, and ethical leadership** are essential qualifications for public office;

NOW, THEREFORE, BE IT RESOLVED, that the Greenville County Republican Party hereby **CENSURES** Dianne Mitchell for her **active participation and leadership role** in the **fraudulent and unethical 2021 ReOrg process**, which undermined the trust and integrity of the Republican Party in Greenville County; and

BE IT FURTHER RESOLVED, that the GCRP shall **publicly distribute this resolution** and share it with **Republican voters, local media, and the South Carolina Republican Party**, to ensure that voters in House District 21 are fully informed about **Dianne Mitchell's record of conduct and failure of accountability**; and

BE IT FURTHER RESOLVED, that this censure shall stand as a **formal notice** that the GCRP cannot support or endorse any individual who participated in or benefited from the **2021 ReOrg FRAUD**, unless and until full accountability, transparency, and restitution are made to the grassroots Republican members of Greenville County.
